Notes for Harold(Hal) Earl Thornton:

Harold (Hal) was born and raised in Plainview, Texas. He attended Highland Grade School, Plainview Junior High School, and Plainview High School. He graduated from Plainview Hi in 1956 and enrolled in Baylor University in August of 1956. He graduated from Baylor with a Bachelor of Business Administration in 1960. Following graduation he served six months active duty with the US Army taking basic training and advanced individual training at Ft Leonard Wood, MO. Following his army service, Hal was employed by the General Adjustment Bureau(GAB), an insurance claims adjusting firm.

The first place of employment was in Carlsbad, NM. He move there from Plainview, TX with all his worldly possessions in the backseat of his 1954 Ford. Life was truly an adventure. He lived and worked in Carlsbad with GAB for two and a half years, and in 1963 he was transferred to Santa Fe, NM. During his time at Carlsbad, he met and married Dorcas Ann Campbell. Their first son Shawn, was born in Carlsbad. They lived in Santa Fe for one and a half years and Hal applied to and was accepted by the University of NM school of law. During the first year of law school, Hal was also enrolled in the NM Army National Guard Officer's Candidate school. He was commissioned a Second Lieutenant June of 1965.
